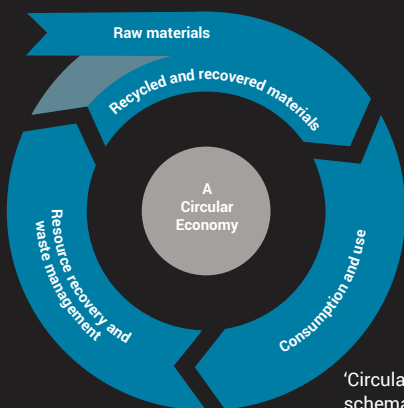

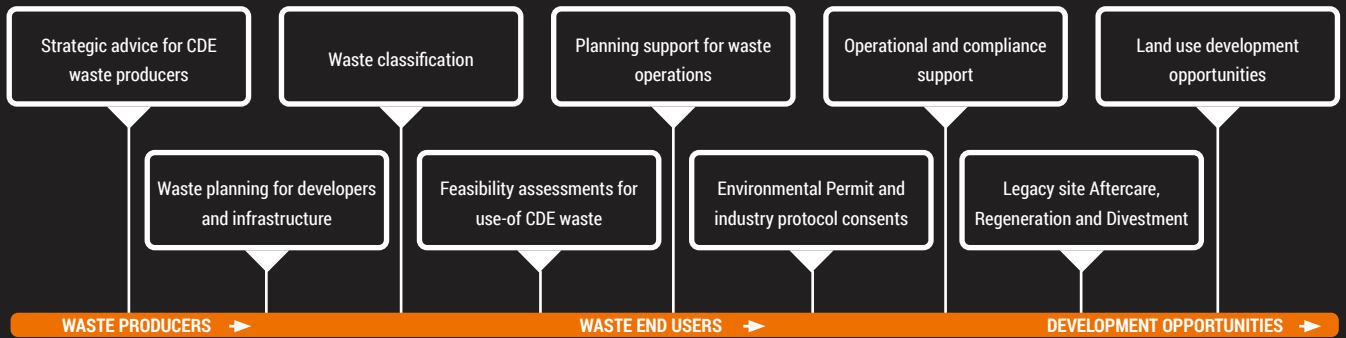


'Circular Economy' schematic from DEFRA
